The FHCP Diabetes and Health Education Program*, teaches you how to take control of your health, lifestyle, and nutrition choices. FHCP's team of Registered Nurses, Registered Dietitians, and Certified Diabetes Care and Education Specialists work with you to provide education, tools, and support to understand and manage your diabetes. Education is done through telehealth (ZOOM) or in person at select FHCP facilities.

 - ✓ \$12, per 31 Tablets - Pioglitazone 15MG, 30MG, 45MG Tablet
- **Syringes and Pen Needles – Available at a low cost from your FHCP pharmacy.**

Specialized Diabetes Supplies such as insulin pumps, and pump supplies require Prior Authorization and are subject to the applicable DME or Medical Pharmacy cost-sharing. Please check your schedule of benefits for cost sharing.



*Covered Services include diabetes outpatient self-management training, educational programs, and nutrition counseling; including all medically appropriate and necessary insulin, equipment, and supplies, used to treat diabetes. The Member's Primary Care Physician, or a Contracted Specialist specializing in the treatment of diabetes, must certify that such services are necessary. Diabetes outpatient self-management training and educational services must be provided under the direct supervision of an FHCP Certified Diabetes Care and Education Specialist or a board-certified Physician specializing in endocrinology. To be covered under this agreement, nutrition counseling must be provided by a licensed FHCP contracted dietitian.
